Note: The afternoon program is not a stand-alone program. It is designed for children who attend in the morning.

One-time Registration Fee - \$40 per child

I understand that summer camp tuition and fees are due within 48 hours of registration and that my child's space is not secured until all enrollment forms have been submitted and summer camp tuition and fees have been paid.

If BWK has not received my summer payments in full within 48 hours or by the first day of my child's scheduled attendance, whichever is sooner, I agree to pay a late fee of 10% of my total balance due, or \$25, whichever is greater. BWK reserves the right to disenroll my child in the event my payment has not been received within 48 hours of registration or the first day of my child's scheduled attendance. When my account is 30 days late or more, based on invoice date, my outstanding balance shall accrue interest at the rate of 2% per month, from the invoice date, until paid in full. I agree to pay all costs of collection for amounts due under this contract including but not limited to attorney's fees and court costs. I agree to pay a \$25 service charge if my check is returned by the bank for not sufficient funds.

I understand that full payment is due even in cases of absence due to illness or travel and that my child may not switch days even in the event of absence due to illness or travel.

EARLY WITHDRAWAL: I understand that the Summer Camp Registration Fee is non-refundable. I understand that written notice 90 days prior to the first day of the session for which I am withdrawing is required. With 90 days of notice prior to the first day of the session in which I am withdrawing, a full reimbursement for summer program tuition is granted for the sessions from which I am withdrawing.

SCHEDULE CHANGES AND REDUCTIONS: I understand that written notice given 90 days prior to the first day of the session for which I am reducing my child's schedule is required. Requests for schedule changes and reductions are subject to a \$45 schedule change fee per session and must be submitted via the online Schedule Change Request Form which is available from the school office. Schedule change requests are subject to availability and are not guaranteed.

The school shall not be liable for any failure or delay in the performance of its duties under this Contract to the extent such failure or delay is caused by a force majeure or other event beyond its reasonable control, including, but not limited to, any fire, act of God, war, government action, act of terrorism, epidemic, pandemic, natural disaster, or other major upheaval. In such an event, the school's duties and obligations under this Contract may be immediately suspended without notice until such time as the school, in its sole and absolute discretion, may safely resume performance. The school may also alter its calendar and scheduled vacations, and/or extend the academic year, in its sole discretion.

Pickup time for the morning program is 12:30pm and does not include lunch. I understand if my child is not registered for the afternoon program and is not picked up from the morning program by 12:30pm, then my child will be placed in After Care and I will be charged a \$5.00 lunch preparation fee and \$20.00 per hour until my child is picked up. After Care ends at 3:30pm. I understand if my child is picked up after 3:30pm, I will be charged \$1.00 per MINUTE which will be given directly to the teacher who stays late to compensate for her or his inconvenience.

I hereby grant to BWK the non-exclusive use of any photograph taken of my child, and of any artwork created by my child while at BWK.

I, the undersigned Parent or Guardian hereby agree to waive, release, discharge, indemnify and hold harmless BWK from any and all claims for damages, death, personal injury or property damage which we may have or may accrue as a result of our participation in BWK's programs and related activities and events. By signing this Summer Camp Contract, I am consenting to my child's participation in BWK's programs and related activities, and I acknowledge that all risks, whether known or unknown, are expressly assumed by me. I also understand that BWK and its agents, officers, employees and designees are not responsible for damages to or theft of personal property.

In the event that I or my child, or my agents, employees or designees, through negligence or an intentional act, cause injuries, damages, or losses to BWK, to BWK personnel, students, parents, teachers, administrators or third parties, the undersigned agrees to indemnify BWK against those losses including but not limited to attorney's fees, costs and damages. This agreement shall be binding and effective upon the undersigned, their agents, successors and assignees.
